### TOURNAMENT RULES

1. This tournament is sanctioned by USBC.
2. Handicap is 80% of 200.
3. Prize fund will be returned 100%.
4. Prize list will pay one place for every 3 entries.
5. All entrants must be members of USBC and the Louisiana Women's State 500 Bowling Club. Members must show USBC Membership Cards before bowling.
6. Entrants shall use their highest average of the previous winter season (2009-2010 USBC/WBA/BA/YOUTH Book Average) in a USBC/WBA/BA/YOUTH sanctioned league for 21 games or more. If no previous winter season average, an entrant shall use the highest average as of the previous summer season (2010), provided they have bowled 21 games or more. If no previous winter or summer league average has been established, an entrant shall use her current league average for 21 games or more as of May 31, 2011, or end of season average. The average must be the highest current league average, regardless of whether bowled as a regular member or a substitute. USBC Rules 319A-2 and 319-E are waived for this tournament. All entrants without a book average must bring verification of their average. All averages are subject to verification; any submitted averages found to be incorrect will be adjusted to the correct average. An entrant who has no average meeting the above requirements must bowl scratch. USBC/WBA Rule 319B.
7. Members may participate only once. Entries must be postmarked by closing date.
8. The tournament is HANDICAPPED. Six (6) games will be bowled by all entrants to determine the Champion of the Club. The first three (3) games will be bowled on one set of lanes and the second three (3) games on another set of lanes. The highest score bowled for the six (6) games in the tournament will determine the State 500 Club Champion. (Duplicate awards will be given in case of a tie for first place.)
- 8a. All entrants will have the option of either bowling all six (6) games on two squads or three (3) games on the Saturday squad and three (3) games on the Sunday squad.
9. USBC/WBA Rule 319d regarding the reporting of prior tournament winnings during the previous twelve months is waived for this tournament.
10. All entrants must check in thirty (30) minutes prior to the scheduled bowling times.
11. Entry fees will be forfeited for non-participation of Entrants.
12. Deadline for entries will be May 13, 2011. Late entries will be accepted until May 27, 2011 and will be subject to lane availability. Please note that entries postmarked after May 13, 2011 will be considered as late entries. Late entries will not have the choice as to the lanes bowled on or team bowled with. **Any entries received after May 27, 2011 will not be accepted.** So please get your entries in early if you have any particular wishes.
13. NSF Checks will be subject to a \$50.00 bank charge and must pay by cash or money order.

### **DIRECTIONS TO THE LANES**

Directions from Lafayette:

Take Hwy 90 East to Morgan City. Take Martin Luther King (Exit 176) and veer right at the bottom of the ramp. Get in the left lane. Turn left onto Hwy 182 at the traffic light. Turn right onto Roderick Street at the next traffic light. Lanes are on the right.

Direction from Baton Rouge:

Take I-10 West toward Lafayette. Veer right at exit for Plaquemine/Port Allen. Turn left toward Plaquemine. Take Hwy 1 through Plaquemine and White Castle. At traffic light in White Castle, turn right onto Hwy 69. Take Hwy 69 to stop sign at intersection with LA 70. Turn right onto LA 70. Follow LA 70 through Pierre Part, Belle River, Stephenville and into Morgan City. Turn left onto Victor II Blvd at traffic light in front of hospital. Take Victor II Blvd to stop sign with Martin Luther King Blvd. Turn right onto Martin Luther King Blvd. Get in left lane and turn left onto Hwy 182 at traffic light. Turn right onto Roderick Street at next traffic light. Lanes are on the right.

Directions from New Orleans:

Take Hwy 90 West toward Houma/Morgan City. Take Exit 176 – Martin Luther King. Turn left at bottom of ramp onto Martin Luther King Blvd. Get into left lane. At traffic light turn left onto Hwy 182. At next traffic light turn right onto Roderick Street. Lanes are on the right.
